| 1 | Ensure physical distancing | <ul style="list-style-type: none"> participants instructed to remain 1.5 metres apart when not competing spectators and club officials instructed to remain 1.5 metres apart where possible |
| 2 | Wear a face mask | <ul style="list-style-type: none"> ALL club officials and spectators MUST wear a face mask when 1.5 metre social distancing rule <u>cannot</u> be maintained Participants are not required to wear a face mask when performing vigorous activity |
| 3 | Practise good hygiene | <ul style="list-style-type: none"> event modified to reduce contact with persons, or cross handling of event equipment EXCEPTION – trained First Aider when administering First Aid |
| 4 | Maintain records and act fast if attendees become unwell | <ul style="list-style-type: none"> attendance record maintained in accordance with Victorian Government and Department Health and Human Services requirements unwell persons exhibiting flu like symptoms are requested to depart the event and seek medical assessment and clearance before returning alternative medical transport is arranged for patient as required – Dial 000 Club to notify DHHS as soon as practicable, when a COVID positive case has been confirmed at an event |
| 5 | Avoid interactions in enclosed spaces | <ul style="list-style-type: none"> Not Applicable = outdoor event current indoor density limits for structures observed as required = 1 person per 4sqm current outdoor density limits for physical activity observed = 1 person per 4sqm |
| 6 | Maintain activity bubbles | <ul style="list-style-type: none"> current outdoor density limits for physical activity observed = cap of 500 patrons activities for senior athletes (30 years and older) = group size limited to 50 |
